Executive Overview

The Check Cashers Act (Act 1216 of 1999) was supported by the payday lending industry and passed the Arkansas Legislature over the opposition of consumer advocates. Nearly seven years after the act became law, the industry is still operating largely without regulation or oversight by the state. The Act is the subject of numerous ongoing court challenges, while publicity about the abuses of payday lending is increasingly resonating with the public.

This Act established a framework to license and regulate payday lending activities in the state, assigning the task to the Arkansas State Board of Collection Agencies (ASBCA). The ASBCA established a Division of Check Cashers to oversee the industry.

Section II of the rules and regulations promulgated by the ASBCA to implement the Check Cashers Act provide that “No person shall engage in the business of check cashing and/or deferred presentment option services without having first obtained a license permit. A separate license is required for each location from which business is conducted.”

A study of payday lenders was conducted by the Arkansas Federal Credit Union in August 2004 and was used as a catalyst in the organization of Arkansans Against Abusive Payday Lending (AAAPL) on September 17, 2004. The study covered payday lenders in the six cities where AFCU had branch offices—Conway, Fort Smith, Jacksonville, Little Rock and North Little Rock/Sherwood—and found that of the 72 payday lenders examined in the study:

- 44 percent had been sued over the charging of usurious interest rates at least once (some multiple times). The usury provision in Article 19, Section 13 of the Arkansas Constitution limits annual percentage interest rates on consumer loans to 17 percent.
- 33 percent did not hold active state licenses, but were still in business anyway.
- 22 percent sought to evade Arkansas law by partnering with out-of-state banks (the “rent-a-bank” model).
- 21 percent sought to evade Arkansas law by creating out-of-state finance companies (the “rent-a-finance company” model).
- 8 percent sought to evade the “rollover” restriction in Arkansas law by using an “internet rebate” model, where the consumer signs a contract to extend the loan every two weeks for a period of 12 months and in addition agrees to “purchase” a useless Internet service from the payday lender.

This report—the first attempt to gather a comprehensive database of all the payday lending outlets in Arkansas—shows that **fewer than half** of the payday lenders operating in Arkansas are licensed with the ASBCA. Furthermore, many of those with license permits are not actually regulated by the ASBCA for their payday lending activities.

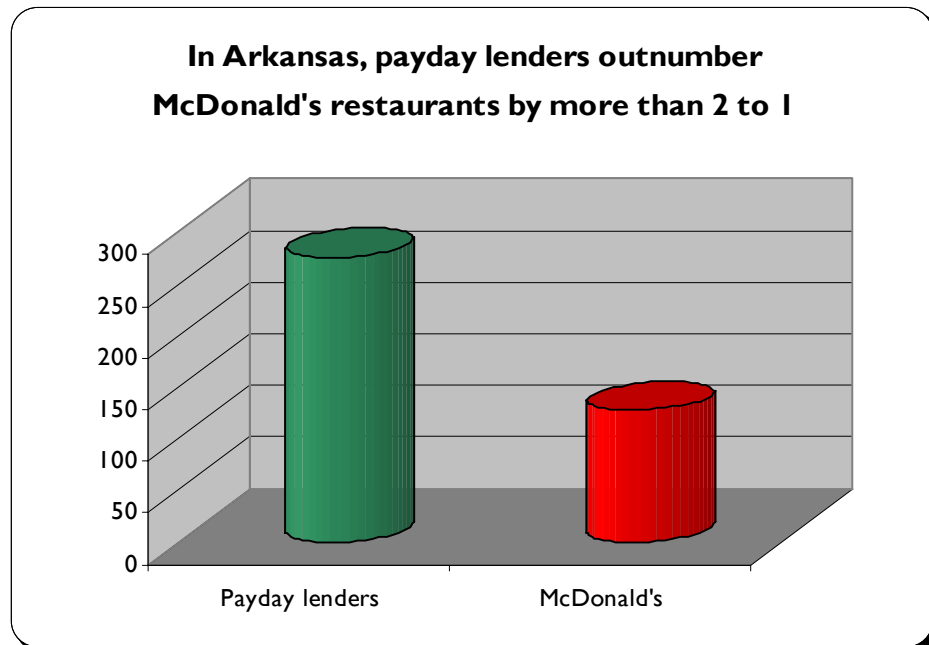
The Check Cashers Act as enacted into law and the statute stated that fees charged by payday lenders “shall not be deemed interest.” A March 22, 2001, decision by the Arkansas Supreme Court found that the General Assembly in passing the Check Cashers Act made an “invalid attempt to evade the usury provisions of the Arkansas Constitution.”

The Supreme Court ruled that Arkansas courts, not the Legislature, are empowered to determine whether fees charged by payday lenders should be considered interest under the Arkansas Constitution’s usury provisions.

More than four years after the Supreme Court decision, the Legislature in Act 1962 of 2005, enacted a law that made “technical corrections” to the Arkansas Code, struck the provision that specifically exempted payday lenders from the Constitution’s usury cap.

Yet payday lenders continue to make loans at triple and even quadruple digit annual interest rates. In order to protect their ability to make loans at usurious rates in Arkansas, payday lenders are using many different modes of operation to continue in business, while at the same time many are evading licensing and regulation by the ASBCA.

The ASBCA lists a database of 171 licensed payday lenders, but research gathered for this report shows that there are actually a total of **275** payday lenders operating in Arkansas as of February 2006. Of those, **209 (76 percent)** are not regulated by the ASBCA—to the detriment of Arkansas consumers.

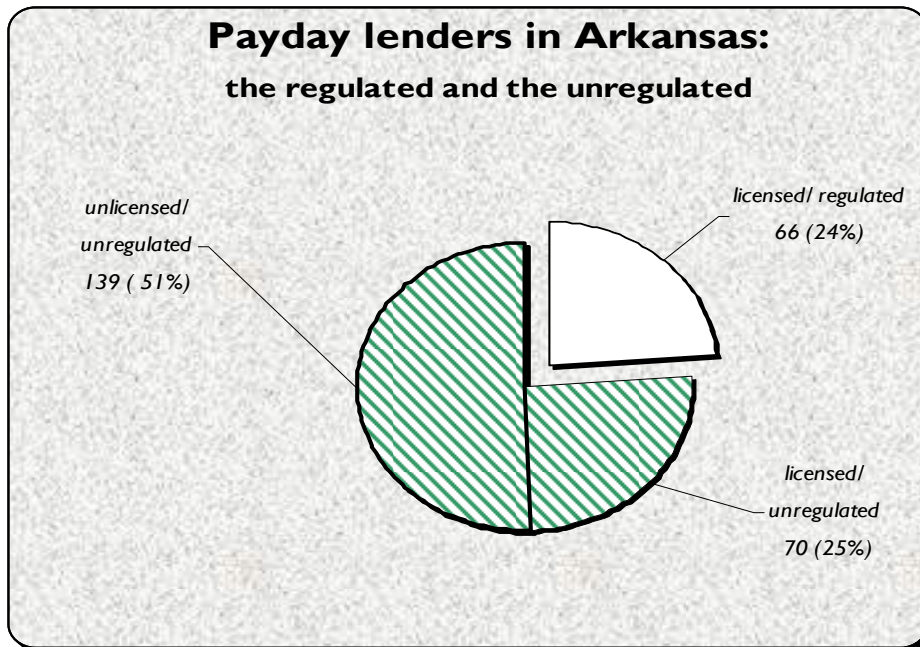


To provide some context, there are 127 McDonald’s restaurants in Arkansas, according to McDonald’s Corporation. So there are more than twice as many payday lenders in Arkansas keeping consumers in perpetual debt as there are McDonald’s feeding them hamburgers and French fries—and for every payday lender that is regulated by the state, another three operate free of regulation.

Furthermore, research shows that of the 171 payday lenders licensed by the ASBCA:

- 66 are actually regulated by the ASBCA.
- 70 are licensed, but not regulated, by the ASBCA to make payday loans due to the ASBCA’s interpretation of the Check Cashers Act.
- 35 are licensed for check cashing activities only and do not currently make payday loans. These stores are not included in the payday lender totals compiled for this report.

In addition to the 70 licensed but not regulated payday lenders, there are another 139 payday lenders that are not licensed, and therefore not regulated, by the ASBCA.



Here is a detailed breakdown of the regulated and unregulated payday lenders in Arkansas:

Payday lenders continue to create various models of operation in order to attempt to disguise these transactions or to cause these transactions to appear to be products other than payday loans and/or loans made by out-of-state banks, finance companies, or payday lenders, even though the majority of the revenues in these lending methods are retained by the payday lenders operating stores in Arkansas.

Worst of all, there seems to be little or no repercussions from the ASBCA for the payday lenders' use of these methods. Indeed, the ASBCA board in recent months has taken actions that significantly reduced the number of payday lenders subject to their oversight and regulation—exempting the 80 rent-a-bank lenders and the 60 rent-a-finance company lenders.

A particularly troubling aspect of these actions is that two of the ASBCA board members who voted to exclude these payday lenders from regulations have financial connections to payday lenders that use the rent-a-finance company model. Ironically, one of these ASBCA board members was appointed to represent “the public at large.”

Other sections of the Check Cashers Act are not being strictly enforced by the ASBCA—including a prohibition payday lenders holding more than one check at a time from the same customers and a prohibition against lenders taking any check in an amount greater than \$400. Direct mailings from many payday lenders and even advertisements at many payday lender locations routinely offer loans of \$500 or even \$750.

Recommendations

The Arkansas Constitution clearly imposes a usury cap of 17 percent per annum on consumer loans, yet payday lenders routinely make loans with equivalent annual interest rates at triple and even quadruple digit rates.

The Arkansas Supreme Court ultimately may rule the Check Cashers Act unconstitutional and compel the Legislature to repeal all or a portion of the Check Cashers Act. If the Supreme Court does not do so, the Governor, Attorney General and the Legislature all have a responsibility to ensure that Arkansas consumers are afforded the protections they are entitled to under the supreme law of the state, the Arkansas Constitution.

No payday lender should be allowed to make consumer loans with interest rates of more than 17 percent per annum. Violators of this constitutional protection should face a criminal penalty and fine.

All payday lenders in Arkansas, no matter their method of operation, should be licensed and actively regulated by the ASBCA to make payday loans in Arkansas. The ASBCA should also require all payday lenders to use a state-contracted database to enforce loan limits and to provide industry-wide data to both regulators and the public on payday lending as a whole. Other states that currently require tracking and reporting are Oklahoma, Florida, Michigan, Indiana and North Dakota. This would provide a much more positive form of protection for Arkansas consumers.

Payday lenders in Arkansas should not be allowed to circumvent the Arkansas Constitution's usury limits by partnering with out-of-state banks, out-of-state finance companies, out-of-state payday lenders, Internet rebates, or other questionable methods.

The “public at large” representative on the ASBCA board should have no connection whatsoever to payday lenders, to ensure that consumer interests are adequately represented.

Background

In the mid-1990s there were fewer than a dozen payday lenders in Arkansas. The Attorney General's office under Attorney General Winston Bryant rigorously enforced Article 19, Section 13 (b) of the Arkansas Constitution which states: "All contracts for consumer loans and credit sales having a greater rate of interest than seventeen percent (17%) per annum shall be void as to principal and interest and the General Assembly shall prohibit the same by law."

Payday lenders lobbied for a law to legalize their unconstitutional activities and were successful in persuading the Arkansas Legislature to pass the Check Cashers Act in 1999. This act was supposed to establish a regulatory structure to ensure that payday lending abuses of the past were controlled by a State of Arkansas regulatory agency.

The agency chosen under the Check Cashers Act to regulate payday lenders was the Arkansas State Board of Collection Agencies (ASBCA). That agency established a Division of Check Cashers to write regulations, license, inspect, and in general regulate payday lenders in Arkansas.

According to the non-profit Center for Responsible Lending <http://www.responsiblelending.org> the average payday loan borrower ends up paying \$800 to borrow \$325. In a typical example, the borrower writes a check for \$377 for a payday loan of \$325, plus \$52 in interest. The money is typically due two weeks later at an annual percentage rate of more than 400 percent.

If the borrower does not have the \$377 to pay back the loan when it is due, they can pay another \$52 fee. This does not pay down the principal; it is simply the interest to keep the loan afloat until the consumer's next payday and then the next, and the next, and so on—this is the "debt trap" of payday lending. More than 90 percent of payday loan recipients receive more than four loans every year, and 99 percent of loans go to repeat borrowers, according to the Center, a research and policy organization that works to eliminate abusive financial practices.

Sections 6 (m) and (n) of the Check Cashers Act specifically prohibit this repeat borrowing, known in the industry as a "rollover," but this practice nonetheless occurs routinely in transactions with payday lenders in Arkansas. Many lenders also routinely ignore the prohibition in Section 6 (n) of the Check Cashers Act limiting any outstanding payday loan to \$400; many payday lenders routinely offer loans of \$500 and even \$750.

A study of payday lenders was conducted by the Arkansas Federal Credit Union in August 2004 and was used as a catalyst in the organization of Arkansans Against Abusive Payday Lending on September 17, 2004. The study covered payday lenders in the six cities where AFCU had branch offices—Conway, Fort Smith, Jacksonville, Little Rock and North Little Rock/Sherwood—and found that:

- 44.44% (32 out of the 72 studied) had been sued over charging usurious interest rates at least once (some multiple times).
- 33.33% (24 out of the 72 studied) did not hold active licenses with the ASBCA, Division of Check Cashers, but were still in business.
- 22.22% (16 out of the 72 studied) sought to evade Arkansas law by partnering with out-of- state banks (rent-a-bank model).
- 20.83% (15 out of the 72 studied) sought to evade Arkansas law by partnering with out-of-state finance companies (rent-a-finance company model). They use Mount Rushmore Loan Company (MRLC) and Dakota Loan Company (DLC) of Sioux Falls, South Dakota.
- 8.33% (6 out of the 72 studied) sought to evade the “rollover” restriction in Arkansas law by using an Internet rebate arrangement.

Arkansans Against Abusive Payday Lending believes that the Check Cashers Act of 1999 is in conflict with Article 19, Section 13 of the Arkansas Constitution which governs usury.

Arkansas is the only state in the union with a usury limit written into the state’s Constitution. In Arkansas that limit protects consumers by limiting interest on consumer loans to a maximum of no more than 17 percent per year. We believe the Check Cashers Act of 1999 will ultimately be determined unconstitutional by the Arkansas Supreme Court because it conflicts with the usury provisions of the Arkansas Constitution.

Additionally, Arkansans Against Abusive Payday Lending based on the research gathered for this report believes that the vast majority of payday lenders in Arkansas are not licensed, inspected or regulated as originally contemplated by the Arkansas Legislature when it passed the Check Cashers Act in 1999. To determine the actual number regulated and unregulated payday lenders actually operating in Arkansas this study was conducted.

Study Results

Initially, licensee information was obtained from ASBCA. Information compiled from the August 2004 study was combined with information gathered for this report. This information was compiled and then verified by on site visits and/or phone calls to payday lenders in all 75 counties.

Over the past 18 months (since the initial study) it appears the work of the Attorney General's office, consumer protection attorneys Arnold, Batson, Turner & Turner and Arkansans Against Abusive Payday Lending has been somewhat successful in combating abusive payday lending. But there is still much more to be done.

Each of these groups has worked to bring attention to activities of the unlicensed lenders. Additionally, the Arnold firm and Arkansans Against Abusive Payday Lending have fought to ensure that the usury provision of the Arkansas Constitution is enforced.

The Check Cashers Act is the subject of numerous ongoing court challenges, while publicity about the abuses of payday lending is increasingly resonating with the public.

A careful look at the payday lenders licensed by the ASBCA (enclosure 1) shows that while 171 licenses are currently issued; only 66 are issued to stores that make payday loans to Arkansas consumers. Thirty-five licenses are issued to stores that only cash checks and do not offer payday loans. An additional 70 licensees do make payday loans, but those activities are not being regulated by the ASBCA because these stores have designed their loans to "get around" the agencies current regulations. The ASBCA unfortunately has allowed these activities to go unchecked to the detriment of Arkansas citizens.

Of those 70 payday lenders with a license to cash checks, the ASBCA has decided not to regulate these same stores for their payday lending activities.

These stores make triple digit interest rate loans (400% to 600% annually) to Arkansas consumers by partnering with out-of-state banks, finance companies and payday lenders as follows:

- 18 are ACE-America's Cash Express stores that partner with Republic Bank & Trust of Louisville, Kentucky, to make Arkansas payday loans.
- 52 are a variety of Arkansas-based payday lending stores owned by and partnered with Mount Rushmore Loan Company (MRLC), Dakota Loan Company (DLC) and Advance Cash of Sioux Falls, South Dakota.

This study update covering the entire state of Arkansas also reveals that 76 percent of the payday lenders (209 out of the 275 we studied) are not licensed to make payday loans or are simply not licensed or regulated at all by the ASBCA—but are still in business.

This has occurred because the ASBCA decided at its November 10, 2004, board meeting that payday lenders using out-of-state banks need not follow the Check Cashers Act and are not to be regulated by the ASBCA.

Additionally, at the next ASBCA meeting on January 26, 2005, the board unanimously agreed that the payday lenders that use out-of-state finance companies also were “not covered by the Check-cashers’ Act of 1999” (enclosures 2 and 2A).

A more positive approach would be to require all payday lenders in Arkansas to be licensed by the ASBCA and to follow that agency’s regulations if the lenders want to offer payday loans in Arkansas. This would provide a much more positive form of protection for Arkansas consumers.

- 29.09% of the payday lenders (80 out of the 275 we studied) are using the rent-a-bank model (enclosure 3). They seek to evade the Arkansas Constitution’s usury provisions by partnering with out-of-state banks that are permitted by bank regulations to “export” the interest rate in the state where the banks’ home offices are located. These eight banks are primarily located in states without any usury rate ceiling such as South Dakota and Delaware.

Three rent-a-bank payday lending chains known to be currently operating in Arkansas are:

- ACE - America’s Cash Express, which partners with Republic Bank & Trust of Louisville, Kentucky, has 20 stores in Arkansas. This payday lender operates a multiline business and in addition to payday loans also cashes checks in each of its offices and therefore is licensed and regulated by ASBCA, but only for the check cashing portion of its business. Their payday Lending transactions are not reviewed or regulated by the ASBCA.
- First American Cash Advance, which partners with Community State Bank of Milbank, South Dakota, has 30 stores in Arkansas. This payday lender operates a monoline business and only makes payday loans. Each of its 30 offices is also unlicensed and unregulated in Arkansas because the ASBCA has chosen to consider these loans to Arkansas consumers as exempt from the Arkansas Check Cashers Act of 1999 and the agency’s regulations.
- Advance America partnered with Venture Bank of Lacey, Washington, until June 30, 2005, when the partnership changed to First Fidelity Bank of Burke, South Dakota, for the 30 Advance America locations in Arkansas. This payday lender also operates a monoline business and only makes payday loans in Arkansas. Each of its 30 offices is unlicensed and unregulated in Arkansas because the ASBCA has chosen to consider these loans to Arkansas consumers as exempt from the Check Cashers Act and the agency’s regulations.

Arkansans Against Abusive Payday Lending disagrees with this no regulation stance taken by the ASBCA and believes that payday lenders in Arkansas should either stop operating in this state or abide by Arkansas law and ASBCA regulations. AAAPL representatives have met with the Arkansas Attorney General in an effort to ensure that **all** payday lenders in Arkansas are licensed with the ASBCA and abide by applicable regulations.

- 21.82% of the payday lenders (60 out of the 275 we studied) are using what we call the rent-a-finance company model (enclosure 4). These Arkansas payday lenders seek to evade Arkansas law by opening an out-of-state finance company (Mount Rushmore Loan Company, Dakota Loan Company and Advance Cash of Sioux Falls, South Dakota) and running their Arkansas loans through these South Dakota shell companies solely to evade Arkansas law and regulations.

Apparently, there is a belief that because banks can export their home office interest rate to other states in which they operate (by federal law) that finance companies can do the same thing. This is the largest single “loophole” being allowed by the ASBCA and has worked so well for the owners of Mount Rushmore Loan Company that they have franchised the process by establishing Dakota Loan Company (DLC).

Payday lenders in Arkansas desiring to evade Arkansas law and the ASBCA regulations can partner with DCL for \$4 per loan (which is an additional fee paid by Arkansas consumers). They make loans in Arkansas to Arkansas consumers without the protections offered to consumers by the Check Cashers Act of 1999 and the regulations and oversight provided by the ASBCA.

Arkansans Against Abusive Payday Lending and the Consumer Federation of America wrote the Arkansas Attorney General on October 15, 2004, in an effort to ensure that all payday lenders in Arkansas are licensed with the ASBCA and abide by their regulations. The Attorney General responded on November 16, 2004, indicating that his office had opened an investigation on two of these companies. We are not sure of the outcome of those investigations.

- 10.55% of the payday lenders (29 out of the 275 we studied) are using the rent-a-payday lender model (enclosure 5). The rent-a-finance company model has worked so well for those Arkansas lenders who evade Arkansas laws and regulations that five Arkansas payday lenders have now opened shell companies in Missouri through which to run their payday loans. This study found that 29 stores are trying to “export” Missouri interest rates and processes into Arkansas. Again the ASBCA has ignored its responsibility to protect the citizens of Arkansas by not requiring these payday lenders to be licensed and to comply with the Arkansas law and regulations.
- 6.18% of the payday lenders (17 out of the 275 we studied) are using an Internet rebate lender model to evade the “rollover” restriction in Arkansas law (enclosure 6). The internet rebate works just like a normal payday loan transaction from a payday lender, except the consumer also signs a contract to roll over the loan

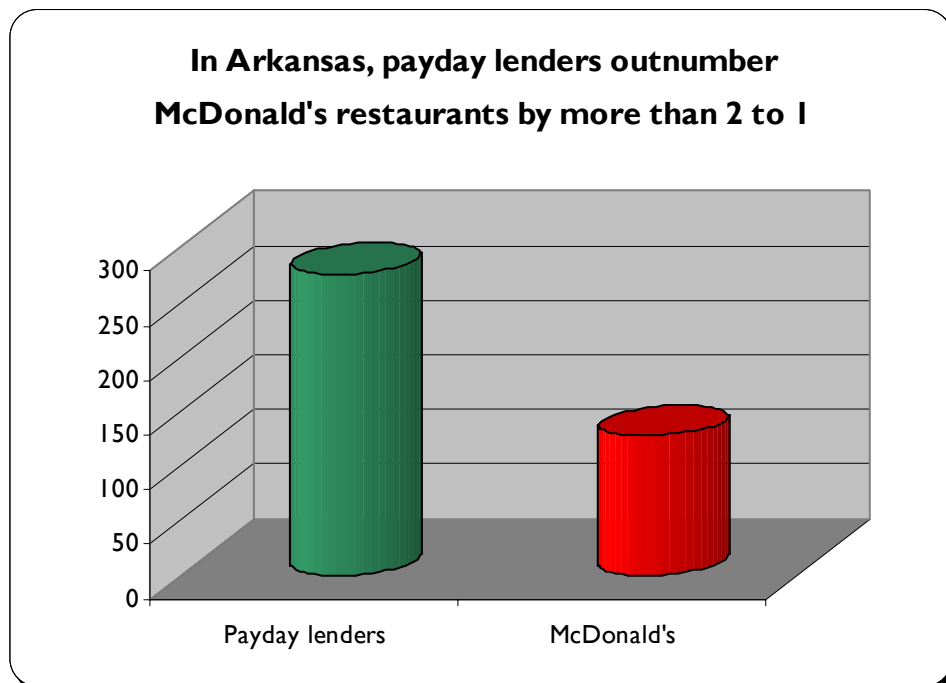
every two weeks for a period of 12 months and in addition agrees to “purchase” a useless Internet service from the payday lender.

We brought this situation to the attention of the Arkansas Attorney General at the time of our previous study in August 2004 when we found six internet rebate lenders operating in the limited area we studied.

The good news is that four of the six we discovered in our previous study have since closed or moved from our state after an investigation by the Attorney General’s office. The bad news is that in this study we have discovered that there are still 17 lenders statewide that are still using the ruse of offering Internet service with rebates that are actually payday loans.

- 8.36% of the payday lenders (23 out of 275 we studied) are just unlicensed lenders seeking to make loans without following any of the laws or regulations established by Arkansas or any other state for that matter.

To provide some context, there are 127 McDonald’s restaurants in Arkansas, according to McDonald’s Corporation. This study identified 275 payday lenders operating in Arkansas. So there are more than twice as many payday lenders in Arkansas keeping consumers in perpetual debt as there are McDonald’s feeding them hamburgers and French fries—and for every payday lender that is regulated by the state, another three operate free of regulation.



How Much Do Payday Loans Cost Arkansas Consumers?

A reasonable estimate of the extent to which payday loans are being accessed can be generated using the number of licensed and unlicensed stores in our state and other industry data. Detailed figures for payday loan sales volume, transactions and fees are not maintained by the Arkansas State Board of Collection Agencies, Division of Check Cashers (ASBCA), which is the state agency that is charged with regulating payday lenders. This is a problem in and of itself that state policy needs to address.

Advance America (a publicly traded company) touts itself as the largest payday lender in the nation. The company's 2004 annual filing with the U.S. Securities and Exchange Commission (SEC) reports that the average amount of its payday loans is \$325, with average fees (interest) of \$52 over an average time period of 15.4 days. This is equivalent to an annual interest rate of approximately 413 percent (in Arkansas for this same loan Advance America would charge \$65.60 or 549 percent).

Advance America in its most recent SEC report also states that it has 2,408 "payday cash advance centers" in 34 states, including 30 stores in Arkansas. According to ASBCA none of those Arkansas stores is licensed or regulated.

According to Advance America's SEC filing for last year, the company made 11,586,000 payday loans through its 2,408 centers. Based on this data, the average number of loans per center is 4,811 per year or an average of 203 loans for every store in the state every 15.4 days (the average time period of the average loan).

Furthermore, the number of licensed payday lenders is by no means a comprehensive picture of the total number of lenders actually operating in the state. The most comprehensive study of payday lending in Arkansas to date found that in August 2004 approximately one-third of the payday lenders surveyed were not licensed with the Division of Check Cashers. The number of unlicensed payday lenders documented in this study increased to 76 percent or 209 of the total of 275 payday lenders in Arkansas.

Assuming Advance America centers make roughly the same number of loans as other payday lenders, knowing that Arkansas has 275 licensed and unlicensed payday lending businesses, and knowing that Advance America charges more in Arkansas than their nationwide average it can conservatively be estimated that there were 1,323,025 payday loans made in Arkansas during the past year.

The measurement of the financial impact of payday loans in Arkansas can be estimated by then multiplying the number of estimated payday loans granted in the past year in Arkansas (1,323,025) by the average fee per loan reported by Advance America (\$52). This suggests that payday loans take potentially \$68,797,300 annually from Arkansas households—money that could be put to better use building consumer's wealth.

Arkansas State Board of Collection Agencies, Division of Check Cashing

This study of the payday lenders operating in Arkansas would not be complete without a brief look into the state agency that licenses, regulates and inspects payday lenders operating stores in Arkansas.

The Division of Check Cashing was added to that state agency that regulates Collection Agencies and Credit Bureaus with the passage of the Check Cashers Act of 1999. The staffing consists of six employees - an Executive Director, Fiscal Manager, two investigators (one serves the Division of Collection Agencies and one serves the Division of Check Cashing), as well as two Administrative Assistants.

The Board of Directors consists of five members appointed by the Governor (enclosure 7). Each member of the board serves a three-year term, without compensation (except for a stipend). Board members represent the following constituencies:

- One member shall be an owner or manager of a Credit Bureau.
- One member shall be an owner or manager of a Collection Agency.
- One member shall be an owner or manager of a check-cashing company.
- One member shall not be a member of these industries, but shall represent the public-at-large.
- One member shall not be a member of these industries, but shall represent the elderly and be 60 years of age or older.

Arkansans Against Abusive Payday Lending has two direct concerns with the makeup of the board and some of its recent decisions. Our first concern is about the board member filling the position to represent the public at large. Our understanding of the selection process for board members is that this position should not represent any industry the agency regulates, but be chosen from the general public. Research has led us to believe this position is currently filled by an officer of a check casher/payday lender that is licensed by the ASBCA.

A second concern is that the “rent-a-finance company” model was discussed in the November 10, 2004, and the January 26, 2005 board meetings of ASBCA. At both meetings the board member representing the public-at-large was in attendance and discussed as well as voted on the issue of whether such payday lenders should be regulated by the ASBCA. From reading the minutes (enclosure 2 and 2a) it does not appear that he advised the other board members that he had a financial interest nearly three dozen stores that are licensed with ASBCA for their check-cashing and payday loan business and for which a decision was about to be made not requiring them to be regulated or inspected by ASBCA for their payday lending activities in the future.

Arkansas Financial Services Association

A study of the payday lenders operating in Arkansas would also not be complete without a brief look into the trade association that purports to represent them. The trade association for the check cashers and payday lenders in Arkansas received its Certificate of Good Standing from the Arkansas Secretary of State on June 11, 1997.

Initially, they were known at the Arkansas Check Cashers Association, but later changed their name to the current name, the Arkansas Financial Services Association (AFSA). The current name mirrors the name of the national association representing payday lenders, the Community Financial Services Association of America.

The AFSA' web site, <http://www.arkansasfinancialservices.org>, states that the site went online to keep AFSA members "better informed about current issues that affect our industry. We will have information from our lobbyist (sic) and our legal team in regard to items that will be of interest to our membership." The "best practices" section and the "newsletter" are both listed as "under construction." In fact there is very little of value for AFSA members on this web site, except for the membership roster itself.

The "Members" page contains a total of 15 individuals who represent both licensed and unlicensed check cashers and payday lenders (enclosure 8). The AFSA by no means represents the entire payday lending industry in Arkansas.

Of the 15 individual members posted on the web site only 6 members, are actually affiliated with one of the 171 licensees of the Arkansas State Board of Collection Agencies, Division of Check Cashers (ASBCA). Those 6 individual members have a total of 23 stores operating in Arkansas, or 13 percent of the 171 stores that ASBCA licenses.

There is an even greater disparity when one looks at just the payday lenders (excluding stores that only cash checks). There are a total of only 5 payday lending stores in Arkansas that are licensed, regulated and inspected by the ASBCA for their payday lending activities and are also members of AFSA—or 3 percent of the total stores licensed by ASBCA.

There is not much difference when you look at both the licensed and unlicensed stores in Arkansas in comparison to the members of AFSA. Arkansas has a total of 35 stores that are licensed and just cash checks. There are also 275 licensed and unlicensed payday lending stores for a total of 310 stores in Arkansas. Additionally, there are a total of 15 individual members of ASFA, or 5 percent of the total licensed and unlicensed stores in Arkansas.

When you look at it from a per store basis there are 81 stores owned by a person who is an individual member of ASFA which represents 26% of the total number of 310 check cashers and licensed and unlicensed payday lender stores operating in Arkansas.

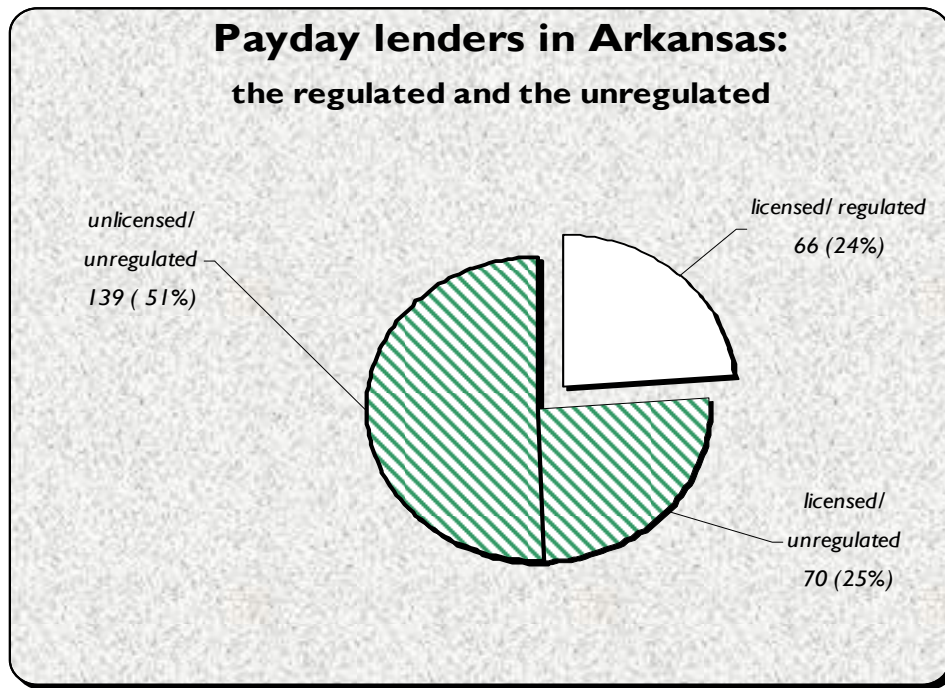
When you consider that only 5 stores or 3% of the licensed payday lending stores in Arkansas are actually represented by membership in Arkansas Financial Services Association that association, their retained lobbyist and legal counsel represent only a very small number of select payday lenders nearly all of which refuse to be licensees and operate under the Check Cashers Act of 1999 and the rules and regulations promulgated by the Arkansas State Board of Collection Agencies, Division of Check Cashers.

Summary

Based upon the information we obtained from ASBCA and the verified information in this study from all 75 Arkansas counties it appears that of the 171 payday lenders licensed by the ASBCA:

- 66 are actually regulated by the ASBCA.
- 70 are licensed, but not regulated, by the ASBCA to make payday loans due to the ASBCA’s interpretation of the Check Cashers Act.
- 35 are licensed for check cashing activities only and do not currently make payday loans. These stores are not included in the payday lender totals compiled for this report.

In addition to the 70 licensed but not regulated payday lenders, there are another 139 payday lenders that are not licensed, and therefore not regulated, by the ASBCA.



Here is a detailed breakdown of the regulated and unregulated payday lenders in Arkansas:

80	29.09% unregulated rent-a-bank
66	24.00% state licensed and regulated
60	21.82% unregulated rent-a-finance company (South Dakota)
29	10.55% unregulated rent-a-payday lender (Missouri)
23	8.36% unregulated payday lenders with unknown models of operation
<u>17</u>	<u>6.18% unregulated internet rebate</u>
275	100%

A complete list of each of the 275 stores providing payday loans in Arkansas (including licensing status and lending methods) is attached to this study as Enclosure 9.

Payday lenders continue to create various models of operation in order to attempt to disguise these transactions or to cause these transactions to appear to be products other than payday loans and/or loans made by out-of-state banks, finance companies, or payday lenders, even though the majority of the revenues in these lending methods are retained by the payday lenders operating stores in Arkansas.

Other sections of the Check Cashers Act are not being strictly enforced by the ASBCA—including a prohibition of customers having more than one check held by the same payday lender at a time and a prohibition against lenders making any loan in an amount greater than \$400. Direct mailings from many payday lenders and even advertisements at many payday lender locations routinely offer loans of \$500 or even \$750.

Worst of all, there seems to be little or no repercussions from the ASBCA for the payday lenders' use of these methods. Indeed, the ASBCA in recent months has taken actions that significantly reduced the number of payday lenders subject to regulation—exempting the 80 rent-a-bank lenders and the 60 rent-a-finance company lenders.

A particularly troubling aspect of these actions is that ASBCA board members who voted to exclude these payday lenders from regulations have financial connections to payday lenders that use the rent-a-finance company model.

Arkansas Code Annotated 17-24-201 sets the provisions for appointment of ASBCA members by the Governor. One member is appointed from a list of three names furnished to the Governor by the Associated Credit Bureaus of Arkansas. Another member is appointed from a list of three names submitted by Arkansas members of the American Collectors Association.

A third ASBCA member appointed by the Governor is supposed to be “selected from the public at large” and not be a member of either the Associated Credit Bureaus of Arkansas or the American Collectors Association. The member of the ASBCA who currently holds the “public at large” position is Treasurer and Controller of a payday lender, according to documents filed with the Arkansas Secretary of the State.

A fourth member must be at least 60 years old and not be actively engaged in or retired from the operation of a collection agency. The fifth member represents the check-cashing industry and is “actively engaged as the owner or manager of a check-cashing operation licensed to do business in the State of Arkansas.”

It is questionable whether the interests of “the public at large” are adequately represented by an appointee who serves as a payday lending company officer.

Recommendations

The Arkansas Constitution clearly imposes a usury cap of 17 percent per annum on consumer loans, yet payday lenders routinely make loans with equivalent annual interest rates at triple and even quadruple digit rates. Act 1962 passed by the 85th General Assembly in 2005 struck the provisions from that Check Cashers Act that specifically exempted payday loan from the Constitutional usury cap.

The Arkansas Supreme Court ultimately may rule the Check Cashers Act unconstitutional and compel the Legislature to repeal all of a portion of the Check Cashers Act. If the Supreme Court does not do so, the Governor, Attorney General and the Legislature all have a responsibility to ensure that Arkansas consumers are afforded the protections they are entitled to under the supreme law of the state, the Arkansas Constitution.

No payday lender should be allowed to make consumer loans with interest rates of more than 17 percent per annum. Violators of this constitutional protection should face a criminal penalty and fine.

All payday lenders in Arkansas, no matter their method of operation, should be licensed and actively regulated by the ASBCA to make payday loans in Arkansas. The ASBCA should also require all payday lenders to use a state-contracted database to enforce loan limits and to provide industry-wide data to both regulators and the public on payday lending as a whole. Other states that currently require tracking and reporting are Oklahoma, Florida, Michigan, Indiana and North Dakota. This would provide a much more positive form of protection for Arkansas consumers.

Payday lenders in Arkansas should not be allowed to circumvent the Arkansas Constitution's usury limits by partnering with out-of-state banks, out-of-state finance companies, out-of-state payday lenders, through internet rebates, or other methods of operation.

The "public-at-large" representative on the ASBCA should have no connection whatsoever to check cashers or payday lenders, to ensure consumer interests are adequately represented.

Who are Arkansans Against Abusive Payday Lending? (AAAPL)

In late 2003 the Arkansas Advocates for Children and Families organized a group of consumer, government and business leaders into a working group called the High Cost of Being Poor Advisory Group. They brought together many diverse organizations to identify practices that prevent families from sustaining adequate incomes or maximizing the income they do receive.

Of the many high cost financial practices identified and studied by this group by far the most egregious practice and most immediate problem to the working poor addressed by this group was payday lending.

At the final meeting of this Advisory Group, H. C. "Hank" Klein, then President/CEO of Arkansas Federal Credit Union proposed the formation of Arkansans Against Abusive Payday Lending (AAAPL). This informal organization of Arkansans is dedicated to improving the lives of the citizens (particularly the working poor) of Arkansas by removing abusive payday lending from our state.

AAAPL has no membership fee, no annual dues, no income, and no expenses. It is simply a gathering together of individuals and groups who will take every opportunity to work with other Arkansans in ridding our state of abusive payday lending.

Today Arkansans Against Abusive Payday Lending is a coalition of members from the following groups: AARP/Arkansas; Arkansas Advocates for Children and Families; Arnold, Batson, Turner & Turner, Attorney-at-Law; Association for Community Organizations for Reform Now (ACORN); AFL/CIO; Better Business Bureau of Arkansas; Central Arkansas Development Corporation; College Station Community Development Corporation; Community Development Department of the City of Jacksonville, Consumer Credit Counseling Service (CCCS); Family Council; Family Service Agency; Family Support on Little Rock Air Force Base; Federal Reserve Bank of Little Rock; League of Latin American Citizens (LULAC); NAACP/Arkansas; Nicolson Communications; Private Citizens; Pulaski County Cooperative Extension Service; Silver Haired Legislators Alumni Association; Southern Good Faith Fund; United Way of Pulaski County; and Victims.

A meeting of the State Board of Collection Agencies was held on November 10, 2004 at 10:00 a.m. in the Board's office in Suite 460 of the Lafayette Building located at 523 Louisiana Street in Little Rock, Arkansas. Board Members Rusty Guinn, Jerry Markham, Opal Lang, and Gary Frala were present. Peggy Matson, Executive Director of the agency and Arnold M. Jochums, Assistant Attorney General were also present.

Rusty Guinn, Chairman of the Board, called the meeting to order.

Freedom of Information Act. The Chairman noted that notice of the meeting had been given in accordance with the Arkansas Freedom of Information Act.

Ms. Matson said that she and Mr. Jochums had met to discuss whether or not cash advances made in Arkansas by storefronts affiliated with out-of-state banks must conform to the provisions of The Check-cashers' Act. She said that they are in agreement that banks and cash advances made by banks are exempt from The Check-cashers' Act. She said that a decision needed to be made as to whether or not cash advance stores that serve as agents for out-of-state lending companies (other than banks) are required to be licensed under The Check-cashers' Act and suggested that the Board make that decision. After some discussion, the Board said that Ms. Matson should make that determination.

As I told you the Board has not approved the minutes of that meeting. However, as you requested, I am enclosing a portion of the draft of the minutes that pertain to that issue:

Ms. Matson asked the Board to make a ruling on whether or not short-term promissory notes offered by out-of-state finance companies are subject to The Check-cashers' Act of 1999. After some discussion, the Board came to a unanimous conclusion that such transactions are not covered by the Check-cashers' Act of 1999.

In response to your second question, no studies or documents were prepared for this discussion with the Board.
